Subject: Hosting and Domain name standardization for Government Websites.

Kindly refer to this office letter Nos. 2/340/2267 dated 03.07.2006, 1/292/195 dated 13.03.2009 and Admn/292/06/1SIT/993 dated 04.02.2010 regarding guidelines for Government Websites.

2. I am directed to inform you that the Web sites of Government and Government owned/ controlled bodies be hosted only on servers and data centers located within India. This is a mandatory requirement to ensure the applicability of relevant Indian laws and compliance with relevant central Government instructions.
3. Further, in order to maintain uniformity across the State, as well as ensure domain name registry jurisdiction, it has been decided that Government Departments/ organizations should use the following domain name suffixes for their websites and applications:

Apex Bodies (Vidhan Sabha), Government Departments, and Commissions	.gov.in
State PSUs (Boards, Corporations and Undertakings) and Statutory Authorities	.org.in
Universities, Government controlled Educational, Academic and Research Institutions	.edu.in, or .ac.in

4. Accordingly, you are requested to take action and ensure the switch over to appropriate domain names by 31.12.2013 positively.
